RE: Quarter Ending 03/31/22 Investment Report

This report is made in accordance with provisions of Gov. Code 2256, The Public Funds Investment Act, which requires quarterly reporting of investment transactions to the Commissioners' Court.

The Brazos County Investment portfolio earned an average yield of .08% on the quarterly average balance of \$11,273,336.94 invested with TexPool, an average yield of .17% on the quarterly average balance of \$72,151,060.90 invested with Texas Class, an average yield of .06% on the quarterly average balance of \$15,682,028.79 invested with Texas Class Government and an average yield of .05% on the quarterly average balance of \$5,056 invested with Dreyfus Cash Management Fund for the period ending 3/31/2022. Investment interest earned and received during the quarter was \$35,412.42. Actual ending balance invested on 03/31/2022 was \$99,127,730.83.

The average rate of interest earned at the county depository was .03%. Interest deposited from PNC for the quarter ending 03/31/2022 was \$2,911.00 for the quarter average depository investable balance of \$162,361,849.00.

Total interest earned for the quarter ending 03/31/22 was \$38,323.42.

Investment Strategy

The Brazos County Investment Strategy remains focused on short-termed investments with the safety of principal as the foremost objective followed by liquidity and yield as per the Brazos County Investment Policy.

Summary of Portfolio Changes

The biggest change in the portfolio is the movement of 60 million from the county depository to Texas Class. The FOMC also announced mid-March to raise the federal funds rate by 25 basis points to .25%-.50%.

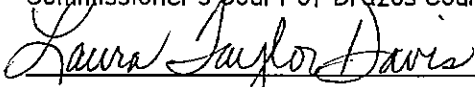

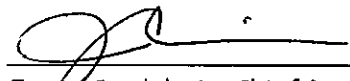
